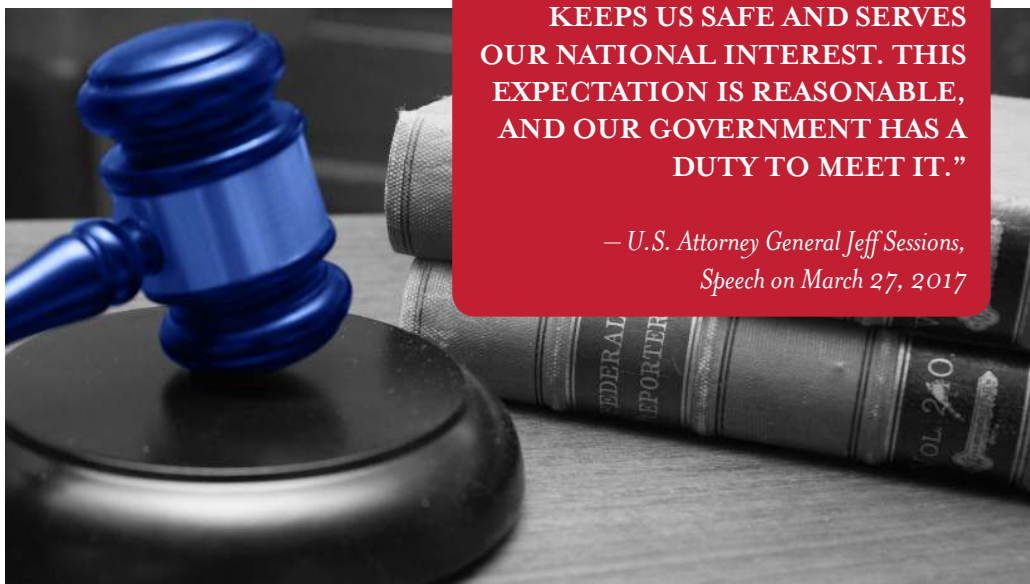
### **WHY IS THIS ATTORNEY NETWORK NEEDED?**
